



GENERAL OBJECTIVES

To contribute to the reduction of the cancer burden in the EU by actions in the areas of:

- >health promotion and prevention
- Screening and early diagnosis
- cancer-related health care
- Co-ordination of cancer research and
- cancer information and data

- 4 are **horizontal**, namely:
- WP1: Co-ordination
- WP2: Dissemination
- WP3: Evaluation
- WP4: Open Forum: 2011 in Madrid, 2012 in Rome and 2013 in Brdo (Slovenia)

- 6. Development of a uniform list of indicators to be used for effective cancer monitoring
- 7. Survey on the current state of National Cancer Plans in the EU member states, Iceland and Norway
